The LVR will ensure its safewoking crews will be trained and competent in all applicable network rules and procedures set out by the relevant Rail Infrastructure Manager LVR plans to operate with.

The Lachlan Valley Railway Society Co op Ltd has developed a set of Operator Specific Procedures, known as LVOPs, to address the specific or unique activities relating to Lachlan Valley Railway Society trains and their safeworking whilst operating on the NSW CRN, Sydney Trains and ARTC NSW Network.

These LVOP manuals are formed along with the LVR Safety Management System (SMS) and must be readily available and on hand to all people within the LVR that require them. They are to be used for reference, as required when rail safety work is being performed. They must be read in conjunction with the rail infrastructure managers network rules and procedures and also in conjunction with the Train Operating Conditions or Route Access Standards manual.

As these procedures are reviewed or updated old copies must be destroyed.

Only the LVR Board of Directors may authorise amendments to LVOP Manuals.
